# About the Pacific Islands Committee

The Judicial Council of the Ninth Circuit established the Pacific Islands Committee to fulfill the oversight responsibilities of the council and of the Judicial Conference of the United States with respect to the judiciaries of the American territories in the Pacific (American Samoa, Guam, and the Commonwealth of the CNMI) and of the former Trust Territories: The Federated States of Micronesia, the Republic of the Marshall Islands and the Republic of Palau. The United States assisted with the formation of the judiciaries in these islands and the Pacific Islands Committee is charged with monitoring their judicial development. Traditionally, the courts of the Pacific administered justice with modest levels of resources.

The specific responsibilities of the Pacific Islands Committee include assisting in the development and provision of continuing judicial education and court professional training, and overall improvement of the administration of justice in the courts. The committee also has oversight responsibility for judicial education grants from the Department of the Interior which provide the funding for the training activities contained in this report.

The Pacific Islands Committee is composed of federal judges appointed by the chief judge of the Ninth Circuit. In FY 2022-2023, the membership included:

# Overview of the Pacific Islands Judicial Education Program

The Department of the Interior appropriates funds each fiscal year to the Ninth Circuit to provide judicial training programs in the Pacific territories and Freely Associated States. This funding, which is mandated by Congress, covers the cost of presenter/staff travel, training materials and the travel costs of attendees for judicial education programs developed for the American territories and former territories in the Pacific. Each year, the Pacific Islands Committee provides the DOI with a written report summarizing the programs and related expenses.

In fiscal year 2023, the courts of American Samoa, the Federated States of Micronesia, Guam, the Marshall Islands, the CNMI and Palau participated in a variety of live training programs developed in conjunction with subject matter experts, the Pacific Judicial Council and the Pacific Islands Committee. These training programs designed to strengthen court governance and the rule of law, improve judicial systems and processes, and develop the skills of newly appointed judicial officers and replace live training during the pandemic-related travel disruptions. The objectives of the training programs are:

- The training of judges to provide fair, impartial, and speedy justice, with a bench imbued with integrity, professionalism and competence.
- The training of court leaders with ethical principles to train court staff and lead courts in the 21st century.
- The training of lawyers to provide a pool of qualified candidates to fill future judicial vacancies.
- The training of court clerks and other court personnel to administer access to justice effectively and efficiently.

# **Program Development**

The Pacific Islands Committee, which oversees the delivery of judicial training in these island jurisdictions, works closely with the Education Committee of the Pacific Judicial Council (PJC) to plan, develop, and deliver judicial training and court development services locally. In addition, the committee works independently with the leadership of the judiciary of the Republic of the Marshall Islands to coordinate training consistent with the goals established by the judiciary's strategic plan and to provide scholarship opportunities to U.S. mainland trainings when those programs best serve the needs of the stakeholders. Compact Funds also support programs developed independently by the courts of the Federated States of Micronesia.

# **Target Audience**

The assessment performed by the National Judicial College identifies the principal target audience for judicial training. This document, along with the FSM and RMI strategic plans, and the leadership of the judges who make up the PJC Education Committee, determine the training priorities each year. In fiscal year 2023, the highest educational needs have included practical skills for judges during to help cope with pandemic restrictions, emotional intelligence, leadership training, environmental law, commercial litigation, ethics, cybersecurity, judicial safety and mental health issues.

# Measuring the Impact of Judicial Training

Each program is evaluated to determine the impact of professional development on judicial (or staff) knowledge, beliefs/attitudes and skills. Evaluation assures that the beneficiaries of this training have the knowledge and skills required to perform their judicial branch responsibilities with fairness and integrity; preserving impartiality and access to the justice system; and ensuring the administration of justice as well as public trust and confidence in the judicial branch.

For each program, ongoing evaluation is carried out to monitor cost efficiencies and evaluate program impact. To enable effective evaluation, precisely defined learning objectives are established for each program developed or attended by a funded participant. Careful evaluation of each program by participants is carried out and a summary reviewed by the program planning committee.

The effectiveness of the judicial education programs developed in FY 2014 in terms of learning gain, attitudinal or behavioral change, and improved professional conduct and performance was measured by a combination of the following:

- Participant satisfaction and self-evaluation forms
- Assessment of learning outcomes
- Reports written and submitted by scholarship recipients and program attendees
- Review of court annual reports.

#### 2023 Programs-at-a-Glance

In fiscal year 2023, 22 judicial education projects were supported by funds from the Department of the Interior. The number of funded programs has begun to normalize to pre pandemic levels. Traditionally the training was designed to accommodate two participants per jurisdiction served, however this limit was waived in 2023 due to overwhelming demand for the training on topics offered. Funding sources include the Technical Assistance Grant for judicial education awarded to the Ninth Circuit for training programs to benefit the judiciaries of American Samoa, Guam, the CNMI, and the Republic of Palau and Compact Funds for the Federated States of Micronesia (FSM) and the Republic of the Marshall Islands (RMI). #### PROGRAM DESCRIPTION

In most civil cases, settlement is more economical for courts and parties. Obvious advantages for the parties include certain and quicker resolutions, and the end of legal expenses. Following settlement, courts need not spend the time and resources required to summon and empanel jurors for lengthy trials.

Judges are often in the best position to navigate the parties toward resolution. However, presiding over a settlement conference requires a judge or mediator to access a different skillset than needed for most other court proceedings. An overview presentation on Alternative Dispute Resolution, or ADR, was provided to Pacific Island participants via Zoom in October 2021. This in-person three-day training for judges and mediators comprehensively explored the following topics through panel and group discussions, practical examples, sample orders, and most importantly, role play:

- The role of a settlement judge/mediator
- Mediation styles
- Confidentiality
- Preparation steps for the conference
- Conducting mediation either in -person or via Zoom
- Stages of mediation through practice scenarios, including role play
- Common questions that arise during mediation and suggested responses
- Addressing impasse
- Mediator's proposal
- How to conclude the conference, whether settlement is achieved or not.

The course was designed for general jurisdiction judges and allowed participants the opportunity to analyze rules of criminal and civil evidence in a setting where they debated the rules with other judges from around the country.

# **Compact Funds**

The base amount of the program was established at \$300,000, an amount adjusted annually for inflation by Section 118 of the Compact of Free Association. In fiscal year 2023 the Pacific Islands Judicial Education Program used funds remaining from FY2021 and FY2022 grants, the FY2023 grant was waived due to the reserve of unused funds from the fiscal years in the pandemic.

The negative balance for the FSM programs were offset by the \$168,107 in funds set aside for program administration but unused during the pandemic years of FY2020, FY2021, and FY2022, leaving a balance of \$181,387 to continue operations through the end of calendar year 2023.
